# Prescribed Fire: A Tool for Managing Forests

Why do environmentalists endorse the use of intentional "prescribed" fire in local forests? Air quality definitely matters to the Sierra Club. Clean air is important – especially for the young, the elderly, and those with health risks. But the reality is that California and most of the West is naturally a fire-based ecosystem with highly flammable vegetation that simply will burn at some point. The only question is "when?" Accordingly, those who live in fire risk communities need to accept the reality that smoke will happen, one way or the other.

At some point, forests, brush fields, and oak woodlands are all likely to burn in a potentially destructive wildfire. Both the Forest Service and the Park Service agree that applying carefully managed prescribed fire is an important tool to reduce the risk of an uncontrolled, high severity wildfire. Some may wonder whether intentionally lighting fires in wildland areas can ever be safe or beneficial. The answer to both questions is "yes."

Prescribed fires are lit and managed by trained fire crews and only when weather, fuel moisture, and air quality conditions are within a pre-planned "prescription." The vast, overwhelming majority of prescribed burns lit on public lands have been done safely and effectively, without getting out of control. Crews create strategic fire lines prior to lighting the fire, and equipment is staged to deal with unexpected events. Additional fire lines are created within the planned burn area so that the prescribed fire can be stopped at those fire lines if conditions change or air quality limits are met. Increasingly, federal forest agencies actually have air quality monitoring equipment on site to ensure that despite the smoke that is generated, no significant health thresholds are exceeded.

For thousands of years lightning and Native American-lit fires kept forests generally open and park-like with scattered patches of forest thickets as well as scattered clearings. The challenge for forest managers today is to replicate natural fires in a safe and effective manner. Our Tuolumne Group consistently supports the use of prescribed fire in our local forests.

## Tuolumne Group Outings Chair Honored by Angeles Chapter with Leadership Award

THE CHESTER VERSTEEG OUTINGS PLAQUE is the highest outings leadership award conferred by the Angeles Chapter. It is awarded to a Sierra Club member who has provided long-term and outstanding leadership in furthering the enjoyment and safety of the outings program.

Keith Martin has been a leader since 1991. He has an M rating. Keith estimates that he has led nearly 1,000 outings for different Angeles Chapter entities, ranging from local conditioning hikes to multi-week international trips to Mexico and Spain. These outings have included dayhikes; local weekend peak climbs; multi-day Sierra backpacks; bus ski trips to Mammoth; bus lodge and backpacking trips to the Grand Canyon; telemark ski lesson trips with instructors at Big Bear and Mammoth; carcamping in Joshua Tree, Anza Borrego, Pinnacles and Morro Bay; day trips to view petroglyphs in Coso Canyon; hiking and ski/snowshoe cabin trips to Yosemite; assisting with navigation check-off weekends in Joshua Tree; week-long volunteer shifts at LeConte Memorial Lodge in Yosemite; leading Volunteer in Parks projects in Yosemite; and leading Natural Science outings to Yosemite, June Lakes and the White Mountains. Frequently, Keith devoted his time to leading or assisting with conditioning hikes to Henninger Flats and the Arroyo Seco. Many of the trips Keith has led have required imagination and the management of complex logistics, such as his trip to Lassen National Park in 2002, which involved flying from LAX to Sacramento, renting cars and then driving to stay in cabins near the park.

Keith has been active with many chapter entities: NSS (current outings chair), PVSB (past chair and outings chair), SMS (past chair and outings chair), SPS (past chair), OCSS (management committee) and WAS (management committee and assistant outings chair). Keith has been active on the chapter Outings Management Committee. He has been the chapter incident investigator for the Safety Committee since 2013. He has been a Navigation Examiner for the Navigation Committee for nearly 20 years.

Since 2010 Keith and his wife Beth have led 16 cabin trips for WAS to Wawona over Martin Luther King Weekend, Presidents Day Weekend and Memorial Day weekend. These trips have netted WAS more than \$8,000. In addition, Keith and Beth led a successful Thanksgiving weekend bus and lodge trip to the Grand Canyon that netted more than \$1,000.

Keith and Beth moved to the town of Groveland in Tuolumne County, near Yosemite, in 2016. They are active with the Tuolumne Group; Keith is the group's Outings Chair and is the Group Representative to Yosemite Stanislaus Solutions, a forest management advisory panel to the Forest Service.

Keith received an Angeles Chapter Outings Service Award in 1999 and a Special Service Award in 2004. The Palos Verdes South Bay Group was also awarded a Special Service Award in 2004, while Keith was Group Chair.

Keith is a licensed professional civil and structural engineer. He is an Air Force Vietnam era Veteran, serving as an officer and a pilot. Keith was a Structural Specialist with the LA County Fire Department's Urban Search and Rescue team, CATF2, and responded with the team to Hurricane Iniki in Hawaii, the Northridge Earthquake, the Oklahoma Federal Building bombing, Hurricanes Gustav and Ike in Houston, and the Port au Prince, Haiti Earthquake.

We congratulate Keith for this much deserved award and for his many years of outings leadership and service!
