TUD Aims for Takeover of PG&E Facilities Including Pinecrest Reservoir

More than 30 years ago, PG&E signed a contractual agreement to provide free water to Tuolumne County in perpetuity as PG&E manages Lyons Reservoir and its power generation facility above Phoenix Lake. That free water is a great deal for the ratepayers of the Tuolumne Utilities District (TUD). But TUD management and Board members aspire to control water that belongs to PG&E and to control and manage all of PG&E's local area facilities. In the name of "local control" TUD appears willing to stick TUD customers with millions of dollars of costs for maintaining and operating Lyons Reservoir, Pinecrest, and the Main Tuolumne Canal − as well as the purchase price for these major facilities -- despite the fact that TUD already gets all the water it needs for free from PG&E. This is not just an economic matter, but it is also an environmental one, since TUD's track record on conservation is very weak compared to PG&E's. ■



State Officials Intend to Develop a "30 X 30" Conservation Plan for California....

Echoing a global theme, State leaders have committed to "conserve" 30% of California by 2030. This "30 X 30" campaign offers activists a chance to promote strong conservation measures as key objectives in the plan. It is possible that under this plan, more areas will be set aside to keep them in a natural, "conserved" condition. Others may attempt to shape the plan to get credit for logging lands, livestock ranches, and orchards as long as those uses minimize impacts to nature. 
Tuolumne Group Recruits Two New Sierra Nevada Alliance Partnership Participants

During their terms of service, James and Robert will help to restore and monitor impaired Sierra watersheds, as well as provide outreach and education to Sierra residents and visitors on environmental issues.




Robert Heim grew up in the San Francisco Bay Area and developed a deep appreciation for the Sierra Nevada mountains while backpacking the John Muir Trail as a youth. A recent graduate from the Bren School at UC Santa Barbara, Robert holds a master's degree in Environmental Science and Management with an emphasis in Conservation Planning. In 2019, Robert interned with Los Padres ForestWatch, where he used GIS to map illegal off-road vehicle sites in the Los Padres National Forest. This experience instilled Robert with an awareness of the threats to public lands, and motivated him to help restore forests that support native biodiversity and provide benefits to human and natural communities. As a 2020-21 SNAP member with the Tuolumne River Trust, Robert works with a dedicated team on forest and watershed restoration projects in the Stanislaus National Forest. He is excited to become involved with the Motherlode Chapter of the Sierra Club, where he will be assisting with youth outreach efforts in Tuolumne County.



James Hart will be serving this year as a Forest Health Specialist with the Tuolumne River Trust. As a native of Tidewater, Virginia, the mountains of California will be a new and exciting place to work and explore. James graduated from the University of Wisconsin-Madison in 2019 with a degree in Conservation Biology, focusing on botany and forest ecology. He spent his summers during college doing trail work in New England and collecting stream ecology data in southern Wisconsin. After graduating, he took part in a short-term position at a salmon hatchery in Alaska and an AmeriCorps term in eastern Washington State. James was drawn to the Sierra Nevada AmeriCorps Partnership by the natural resource challenges the region faces and the good that service work can do in furthering conservation goals. He looks forward to partnering with the Motherlode Chapter of the Sierra Club over the coming year and assisting with the group's environmental outreach work here in Tuolumne county. When he's not working, you can find him cycling around, hiking, or playing his guitar.

Working with both the Tuolumne River Trust and the Sierra Club, Robert and James will engage with key environmental issues in the Calaveras and Tuolumne regions, gain first-hand field experience in watershed conservation/restoration, and add an impressive accomplishment to their resume. Our Group will benefit greatly from their expertise and youthful enthusiasm.
